Supreme Court Internal Operating Procedures are hereby amended, effective February 7, 2005, to read as follows:

I. General Rules, paragraph 5:

Each justice shall select and appoint one research attorney and one executive-secretarial assistant, who shall be directly responsible to the appointing justice. The Chief Justice shall also select and appoint an attorney to serve as special administrative assistant, who shall be directly responsible to the Chief Justice. A judicial administrator shall be appointed by the ~~Chief Justice~~ Supreme Court to serve at the will of the ~~Chief Justice~~ Supreme Court. The judicial administrator shall be responsible to the ~~Chief Justice~~ Supreme Court, shall implement the policies of the court under the supervision of the Chief Justice and shall perform such other duties as are provided by law or by the Supreme Court or the Chief Justice. ~~K.S.A. 20-318~~.
