State the question, then give the answer.

Statutes require a district magistrate judge: (1) be a graduate of a high school or secondary school or the equivalent; (2) be a resident of Osage County at the time of taking the oath of office and at all times while holding office; and (3) be either a lawyer admitted to the practice law in Kansas or a nonlawyer who, within 18 months of taking office, passes an examination given by the Supreme Court and becomes certified, as provided by K.S.A. 20-334(b) and K.S.A. 20-337.

1. Schools and colleges you have attended, diplomas, degrees, and dates.

7. Have you ever held judicial office or been a candidate for judicial office? If so, state the courts involved, the dates of service, or dates of candidacy.
8. Have you ever held or been a candidate for any other public office? If so, state the office, location, and dates of service or candidacy. If you currently hold such office, would you be willing to resign from this position?
9. List any professional writings or lectures, stating the nature.
10. List any social media accounts, webpages, blogs, or similar types of internet presence that you own or maintain, either personally or professionally. Provide corresponding handles or names by which you would be identified.
11. List all professional associations and societies of which you are a member, and give the titles and dates of any office which you may have held in such groups and committees to which you belong(ed) and offices held.
12. For the last five years, list, in a fully identifiable fashion, all civic, charitable, sports-related or cultural organizations of which you have been a member, including the titles and dates of any offices which you have held and the activities in which you have been or are engaged in each such organization.
13. Are you a director, officer, or holder of stock of more than \$5,000 in value of any business or corporation? Is there any such connection you would not be willing to sever if the relationship resulted in your frequent disqualification as a judge?
14. Are you a member of any partnership or joint venture? Is there any such connection you would not be willing to sever if the relationship resulted in your frequent disqualification as a judge?
15. Do any of your family members have a business relationship or investments which would result in your frequent disqualification as a judge?
16. Have you ever been sued? If so, give particulars, including case numbers.
17. Have you ever been a party in any other legal proceeding? If so, give the particulars. Include all legal proceedings in which you were a party in interest, including divorce proceedings; a material witness; a named co-conspirator or co-respondent; and any grand jury investigation in which you figured as a subject, or in which you appeared as a

witness. Do not list proceedings in which you were sued only in a representative capacity (e.g., guardian ad litem).

18. Have you ever been the subject of public discipline imposed by a professional disciplinary body, subject to a fee dispute, or found in contempt? Explain. In each case state in detail the circumstances and the outcome. Please include complaints.
19. Have you ever filed for bankruptcy? If so, please explain.
20. Do you presently have any noncurrent unpaid tax obligations? If so, please explain.
21. Has any tax lien or other collection procedure ever been instituted against you by federal, state or local authorities? In particular, have you been the subject of any proceeding, criminal or civil, initiated against you by the Internal Revenue Service or a state department of revenue? If so, give particulars, including case numbers.
22. Do you currently use illegal drugs? Illegal use of drugs means the use of one or more drugs, the possession or distribution of which is illegal under the laws of Kansas or of the United States. If so, please explain.
23. List the names, addresses, and phone numbers of at least five persons who are in a position to comment on your qualifications, general character and background and of whom inquiry may be made by the commission without embarrassment to you.
